2. Mental Health Clinician: This position is year-long in its schedule.

For both positions, work assignments could be at school sites, homes, at one of our offices (Cameron Park, Placerville, and Pollock Pines), and our runaway/homeless youth shelter if needed. You would provide group, individual, and family counseling to youth and their families.
